

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.whatGodhasdoneforme.com and whatGodhasdoneforme.com and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to whatGodhasdoneforme.com include www.whatGodhasdoneforme.com and WGHDFM. The WGHDFM website is a Social Network Site site. By using the WGHDFM website, you consent to the data practices described in this statement.

Collection of your Personal Information

WGHDFM may collect personally identifiable information, such as your name. WGHDFM may also collect anonymous demographic information, which is not unique to you, such as your age, gender and religion. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by WGHDFM. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the WGHDFM website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through WGHDFM's public message boards, this information may be collected and used by others.

Use of your Personal Information

WGHDFM collects and uses your personal information to operate its website(s) and deliver the services you have requested.

WGHDFM may also use your personally identifiable information to inform you of other products or services available from WGHDFM and its affiliates. WGHDFM may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

WGHDFM does not sell, rent or lease its customer lists to third parties.

WGHDFM may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party.

WGHDFM may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to WGHDFM, and they are required to maintain the confidentiality of your information.

WGHDFM will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on WGHDFM or the site; (b) protect and defend the rights or property of WGHDFM; and, (c) act under exigent circumstances to protect the personal safety of users of WGHDFM, or the public.

Use of Cookies

The WGHDFM website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize WGHDFM pages, or register with WGHDFM site or services, a cookie helps WGHDFM to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same WGHDFM website, the information you previously provided can be retrieved, so you can easily use the WGHDFM features that you customized.
